

Pursuant to the decision of the High Power Committee in its meeting held on dtd. 17.8.19 and as per the guidelines issued by the Government in the Department of School & Mass Education, Odisha, Bhubaneswar, vide Resolution No. 30720/SME dtd. 23.9.96 read with G.O No. 29519/SME dtd. 26.9.1998, ^{Confidential} No Objection Certificate (NOC) is hereby granted in favour of **NRI International School, Bhadrak** for a period of one year to open Self Financed High School upto class-X which is to be affiliated to **CBSE** subject to following terms and conditions. The extension of NOC beyond one year will be considered after ensuring fulfilment of the terms & conditions.

1. The No Objection Certificate now issued shall be subject to the terms & conditions as prescribed in G.O No. 30720/SME dtd. 23.9.96 and No. 29519/SME dtd. 26.9.1998 read with G.O No. 10011/SME dtd. 11.6.2004.
2. The school shall be open to inspection by the Officers of S & ME Deptt. as and when required.
3. No Financial Assistance or Grant-in-Aid (either recurring & non-recurring) will be claimed by the institution from the Government at any point of time to meet any kind of expenditure towards salary cost or any non-salary requirement.
4. The High Power Committee shall be competent to review the NOC granted to the Institution concerned and shall be competent to withdraw the same if any of the terms and conditions mentioned in this NOC is violated.
5. The Managing Committee shall be constituted in accordance with the Sec-7 of the Orissa Education Act-1969.
6. The school shall not be shifted from its present location without prior approval of Director, Secondary Education, Odisha.
7. At present the School land is not in the name of the School. It will be the responsibility of the Management to record the required land (1.5 Ac.) in School name and copy of RoR submitted within six months to the Directorate.
